EQORIA FIRST CITIZEN BOND CERTIFICATE AGREEMENT

This Agreement governs the purchase, sale, delivery and acceptance of Dartcoin between EQORIA and the Citizen. The terms used in this Agreement have the meaning set out in the Annex 1.

1. Delivery of DARTCOIN

EQORIA shall deliver or cause to be delivered the Contract Quantity of DARTCOIN on the Dartcoin Address of the Citizen on or before the Delivery Date and Time. Proof of delivery will be the inclusion of the transaction in the second block published by the Ethereum network after the Delivery Date and Time.

2. Failure to Deliver

In case EQORIA fails to deliver the Dartcoin according to section 1, EQORIA shall pay the Citizen as compensation for damages an amount for such undelivered Dartcoin equal to the product of: (a) the amount, if positive, by which the price, if any, at which the Accepting Party acting in a commercially reasonable manner is or would be able to purchase or otherwise acquire in the market the quantity of undelivered Dartcoin exceeds the Contract Price; and (b) the quantity of undelivered Dartcoin.

3. Payment

A.

The Citizen shall pay EQORIA no later than the Due Date in the amount of equal to the Dartcoin Entry Price times the Dartcoin Quantity, which are set in Annex 1 of this agreement.

B.

The purchased amount and the first citizen level is specified at Annex 1 which is attached to this agreement.

C.

The Citizen shall pay the purchase amount into Dartcoin wallet at Annex 1 which is attached to this agreement.

4. Overdue Payments

Overdue payments shall accrue interest from, and including, the Due Date to, but excluding, the date of Payment at the Interest Rate.

5. Confidentiality

Parties will not disclose the terms of this agreement to any third party unless ordered by a valid court order.

6. Term and termination

This agreement remains in force until the latter of:

- delivery of the Dartcoins at entry price.

- payment for Dartcoins (including late payments and the penalty for non-performance)

- return of Dartcoins at exit price with the payment back to citizens in the currency of choice

7. Dispute Resolution

This agreement is governed by the laws of the EQORIA United Citizens of Earth and any disputes arising in connection with this agreement shall be referred for resolution to the courts of the EQORIA Earth Consortium.

8. Execution of this agreement

a. This agreement is accepted and executed with the signature of the citizen provided in Annex 1 of this agreement

b. Annex 1 constitutes a part of this agreement, and thus it is legally binding.
